A BYLAW OF THE MUNICIPAL DISTRICT OF OPPORTUNITY NO.17  
TO AMEND BYLAW 2007-26 BEING THE HAMLET OF WABASCA AREA STRUCTURE PLAN AS  
AMENDED

**WHEREAS** the Council of the Municipal District of Opportunity No. 17 deems it in the public interest to amend Bylaw 2007-26 being the Hamlet of Wabasca Area Structure Plan, as amended, as it affects certain lands.

**NOW THEREFORE** the Council of the Municipal District of Opportunity No. 17 in the Province of Alberta pursuant to the authority conferred upon it by the Municipal Government Act, R.S.A. 2000, as amended ("the Act"), enacts as follows:

1. Bylaw 2007-26 being the Hamlet of Wabasca Area Structure Plan, as amended, is hereby further amended as follows:

A. **That Map 1: the Future Land Use Plan, is amended by classifying the following lands, which are currently classified as Residential Land Use Area to Commercial Land Use Area:**

i. Part of Plan 862 2598, Block A, Lot 0

The area to be classified **Commercial Land Use Area** is shown on Schedule "A" of this Bylaw.

This Bylaw comes into effect upon the date of the final Reading thereof.

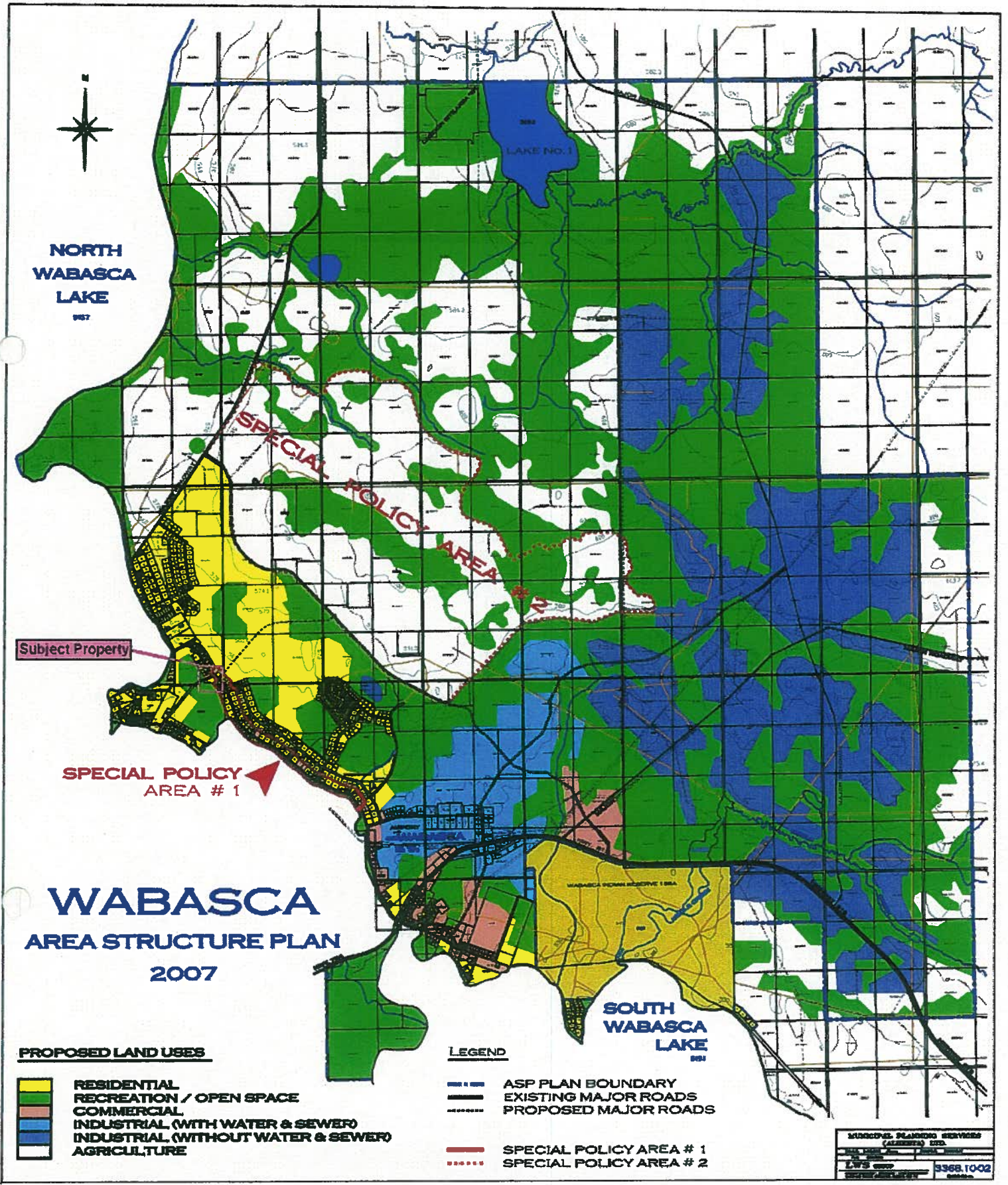
