The province entered into an agreement with Bigstone Cree Nation, Loon River First Nation and Peerless Trout First Nation. The United Northern Partnership Agreement is a project that aims to connect Fort McMurray and Peerless Lake with a 218-kilometer, two-lane gravel highway in Alberta. They are working collaboratively with the government.

Phase 1 is from Red Earth Creek to Peerless Lake which is 65 km and phase 2 is from Peerless Lake to Fort McMurray.

The feasibility study is a business case for a potential RCMP detachment in Calling Lake. It is a grant funded project. 78% of residents that did the survey support a local detachment. Policing gaps were identified. Benefits of having a detachment are community safety, economic benefits and social impacts.
