**Metal Signs Discussion:**

Direction to defer the potential Metal Signs project to the Recreation Committee to define the scope, determine location and quantity. Administration will prepare a scope document with cost estimates and consider budget for 2024.

There was a brief discussion about the transfer of the Calling Lake Senior Housing units to Wabasca Desmarais Housing Authority. The units will be transferred when the subdivision is complete.

The delegates were in attendance to present the STARS update to council. Since 2010, STARS has transported 74 patients within the MD of Opportunity boundaries. Missions and critical medical transfers have increased across the province.

The interior of the air ambulance has highly specialized equipment that can provide critical care anywhere. They recently put a fuel cache in Athabasca. STARS is also working with Alberta Health Services to look at having heliports at all hospitals.

Glenda and Jon thanked MD of Opportunity for their ongoing support. The continued support is a leading municipal partnership.
