Josh Friessen – Community Futures Lesser Slave Lake

The delegate was in attendance to present to council the proposals for Preparing for Community Growth Project, Learning for Community Growth Project, and Accept Care and Elevate (ACE) Project. He is also seeking letters of support for the projects and an investment

of \$8,000 to support the development of these studies/packages.

The Preparing for Community Growth project and initiative is spearheaded by Community Futures Lesser Slave Lake. This project is strategically designed to support the preparations for economic growth in the Lesser Slave Lake Region. The program is to help set up a learning platform for the area. It will be developed for teaching online entrepreneurship, customer service, basic skills, and live courses throughout the region. The program enables communities to stand out in a competitive market by: a) showcasing unique selling points, b) build credibility by providing reliable, actionable data, and c) engage potential investors with professional and persuasive materials, and d) foster long-term relationships with stakeholders, creating a foundation for sustained economic growth. Community Futures is applying to the Northern Regional Economic Development Program for funding to administrate and launch the Preparing for Community Growth project.

The Learning for Community Growth project is strategically designed to bolster entrepreneurship capacity and elevate workforce skills. The approach includes building an online learning program, provide in-person training opportunities for entrepreneurs and workforce training. Community Futures is applying to the Small Community Opportunity Program for funding and is seeking a letter of support for this program.

The Accept Care and Elevate (ACE) project stands as a visionary, community-driven initiative dedicated to nurturing cultural exchange, celebrating diversity, and fostering unity within our vibrant communities. This initiative is anchored by three pivotal services: a) Expended Ethnocultural Celebration Campaign, b) Hockey as a Second Language and c) Culture Pockets. Community futures is applying to the Ethnocultural Grant Program and is seeking letter of support for this program.
