BYLAW 2017 - 11

BEING A BYLAW OF THE MUNICIPAL DISTRICT OF OPPORTUNITY NO. 17 TO AMEND BYLAW 2013-14, THE LAND USE BYLAW OF THE MUNICIPAL DISTRICT OF OPPORTUNITY NO. 17, AS AMENDED AND TO AMEND BYLAW 2008-1 BEING THE HAMLET OF CALLING LAKE AREA STRUCTURE PLAN AS AMENDED

WHEREAS Section 191 of the Municipal Government Act, RSA 2000 c M-26, provides that a Municipal Council may amend Bylaw of the municipality;

WHEREAS the Council of the Municipal District of Opportunity No. 17 deems it in the public interest to amend Bylaw 2013-14 being the Land Use Bylaw, as amended, and Bylaw 2008-1 being the Hamlet of Calling Lake Area Structure Plan as they affects certain lands;

NOW THEREFORE the Council of the Municipal District of Opportunity No. 17 in the Province of Alberta pursuant to the authority conferred upon it by the <u>Municipal Government Act</u>, R.S.A. 2000, as amended ("the Act"), enacts as follows:

- 1. Bylaw 2013-14 being the Land Use Bylaw, as amended, is hereby further amended as follows:
 - A. That Insert Map 11.2.1 A-1: Hamlet of Calling Lake in Section 11.2, is amended by:
 - a. Redistricting that portion of Lot 1, Block 11, Plan 902 0094 from C2 Commercial District to the R1D Residential District as shown on the attached Schedule "A"; and
 - b. Redistricting that portion of Lot 2, Block 11, Plan 902 0094 from R1D Residential District to the C2 Commercial District as shown on the attached Schedule "A"
- 2. Further, that Bylaw 2008-1 being the Hamlet of Calling Lake Area Structure Plan, as amended, is hereby further amended as follows:
 - A. That Map 1: the Future Land Use Plan, is amended by:
 - a. Classifying those portions of Lot 2, Block 11, Plan 902 0094 from Cultural/Recreational Policy Area to Residential Policy Area as shown on the attached Schedule "B"
 - b. Classifying those portions of Lot 1 and Lot 2, Block 11, Plan 902 0094 from Residential Policy Area and Cultural/Recreational Policy Area to Commercial Policy Area, as shown on the attached Schedule "B".

This Bylaw comes into effect upon the date of the final Reading thereof.
