FRIAA – Sherry Norton, Round Table Introductions

The delegate was in attendance to address the concerns raised regarding the Calling Lake Fireguard project and explained what the funding could and could not cover. This grant is for fireguard projects and can't be used for different projects such as FireSmart. FireSmart is a different application that doesn't fit under the fireguard program.

She went over the timelines. It was the government's intention to have the phase 1 projects done by the end of March 2021. It would be a default of the agreement if the project isn't done by the end of March 2021.

MD could apply to postpone the project for a year but there are risks and complications. The province may most likely open it up to other communities and get it done by end of March 2022. Funding may not be available next year.

Some options discussed were to change the scope of the project to the current agreement. Option to change the width and length of the project. The MD could apply for an extension but it's not guaranteed it would be approved.

Council asked questions about the possibility of transferring to another community in the MD and stay on same timeframe.
