The focus for their attendance was to propose an MOU (Memorandum of Understanding) agreement drafted between the M.D. of Opportunity and PTFN (Peerless Trout First Nation) similar to the one that is in existence with BCN (Bigstone Cree Nation).

In addition, Chief Alook informed Council that PTFN purchased a camp and it is based just outside of Peerless Lake as well as a cement plant for business opportunities.

The CAO explained that he will be in Peerless Lake on Wednesday July 31st and will set up a meeting with the PTFN's Manager to review possible contents for the MOU agreement. Once an MOU is drafted, it will be brought back to Council for their review.

William Houle explained that PTFN will be spending \$250,000.00 for the construction of a new covered outdoor rink. Reeve Sinclair informed the delegates that the MD will need to review the plans for the structure so that the engineers can confirm structural integrity.

Chief Alook inquired as to when the Community Hall would be re-opened as they would like to utilize it for their Treaty Day Event coming up in August. The CAO informed him that it should be ready for re-opening in August.
